About the Office of Community Complaints

Our Mission:

Under the authority of the Board of Police Commissioners, the Office of Community Complaints (“Office”) is a non-police, civilian oversight agency. The Office has been charged with the responsibility of protecting the complainant from the possibility of abuse or misconduct on the part of the Kansas City, Missouri Police Department. The Office is also entrusted with the duty to protect members of the police department from unjust and unfair accusations. The Office of Community Complaints is committed to effectively and impartially resolving all complaints involving a person’s guaranteed right to fair and efficient police protection.

In fulfillment of its mission, the Office has pledged to:

- Encourage members of the community to file complaints when they feel they have experienced police misconduct.
- Encourage active participation by all parties in the complaint process.
- Examine carefully each investigative file so as to ensure that all efforts have been made to resolve the complaint.
- Review all complaints with complete objectivity and impartiality.
- Respect and protect the rights of both the complainant and the subject member.
- Engage in community outreach throughout Kansas City, Missouri to educate the general public concerning the agency’s purpose.
- Report to the Board of Police Commissioners any patterns of misconduct that are uncovered as a result of investigations and complaint review.
- Report to the Board of Police Commissioners any and all relevant issues and policy matters that may arise.
- Proactively identify trends that may need to be addressed by the Regional Police Academy for officer training.

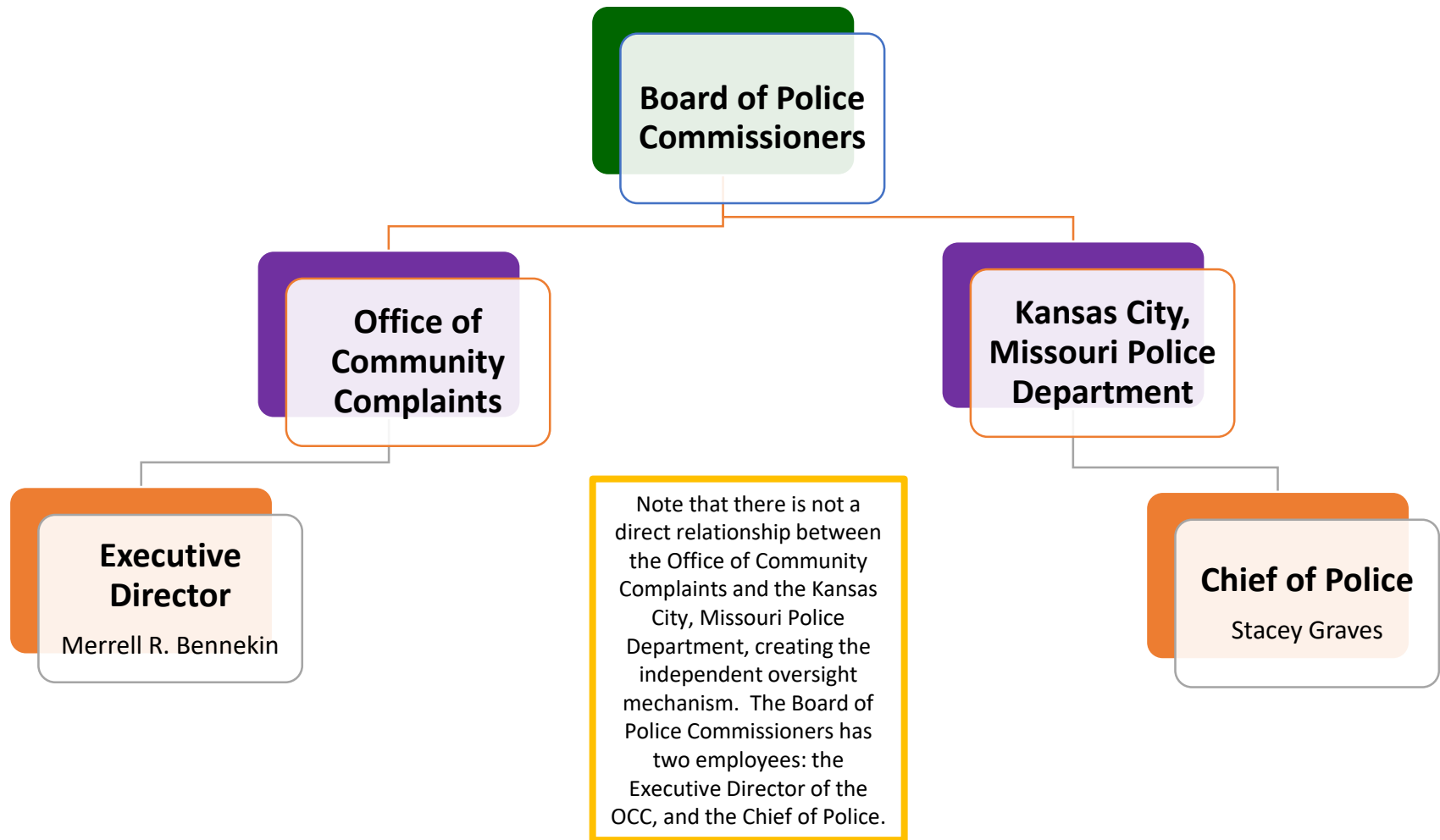

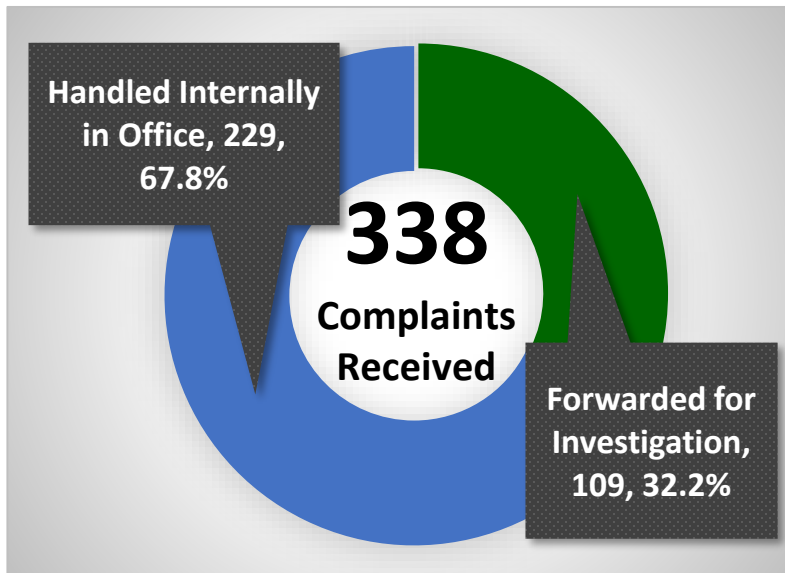
Organizational Structure



By the Numbers: 2024 in Review



2024 by the Numbers



In 2024, 338 complaints were received in the Office of Community Complaints. This represents a 1.2% increase over the number of complaints filed in 2023 (334).

Complaints **Forwarded for Investigation** were sent to the Internal Affairs Unit of the KCPD for an investigation into the allegations.

Complaints **Handled Internally in Office** were handled through mediation, conciliation, or were outside the purview of the office and were administratively closed. These complaints are also referred to as “Non-Investigated Complaints” (NICs).

In 2024, in an effort to more accurately define the complaints that were received, the Office implemented a “Non-KCPD Complaint” category. More information can be found on the next page about this category.

Compared to 2023:

1.0% Increase

There was a 1.0% increase over the number of complaints received in 2023 (334).

7.8% Decrease

There was a 7.8% decrease in the number of complaints forwarded for investigation from 2023 (139).

8.5% Increase

There was an 8.5% increase in the number of complaints handled internally from 2023 (195).

Complaint Categories

Bias-Based Policing

The police actions of a member were substantially based on the race, ethnicity, gender, age, sexual orientation, religious beliefs, disabilities, or national origin of a person, rather than upon lawful and appropriate police procedures.

Discourtesy

The actions or statements of a Department member were in violation of the Code of Ethics or Rules of Conduct based upon the context of the contact with the complainant. For example, the use of ethnic slurs would be classified as discourtesy.

Excessive Use of Force

A member of the Department used more force than reasonably necessary to arrest a suspect, take a suspect into custody, stop a suspect for investigation, control a situation, and restore or maintain order.

Harassment

Where a member of the Department has had repeated or continued contact with a person without lawful police justification.

Improper Member Conduct

The behavior of a member was unprofessional, unjustified, beyond the scope of the authority of the member, unauthorized by Department procedures, or constituted an unreasonable lack of police service.

Improper Procedure

An administrative or procedural requirement was not met. This includes, but is not limited to improper search and seizure, omission of the Miranda Warning when required, etc.

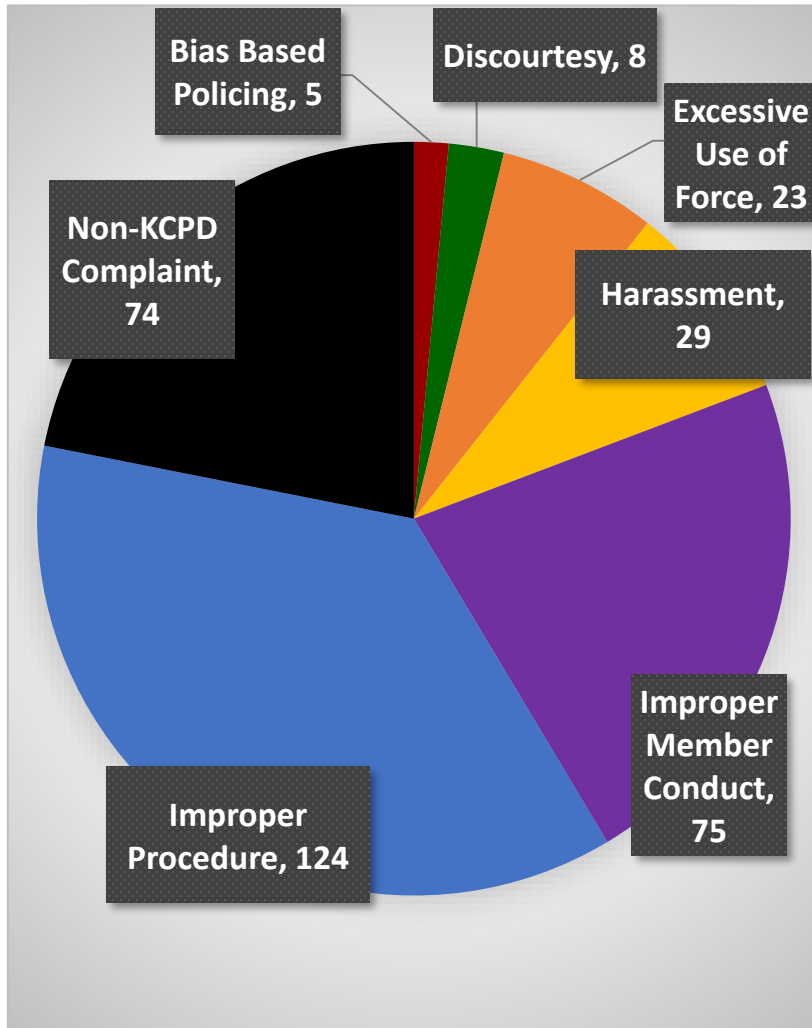
Non-KCPD Complaint

The complaint is against a person or entity not associated with the KCPD, and thus, the Office has no jurisdiction to handle these complaints. This category was first introduced in 2024.

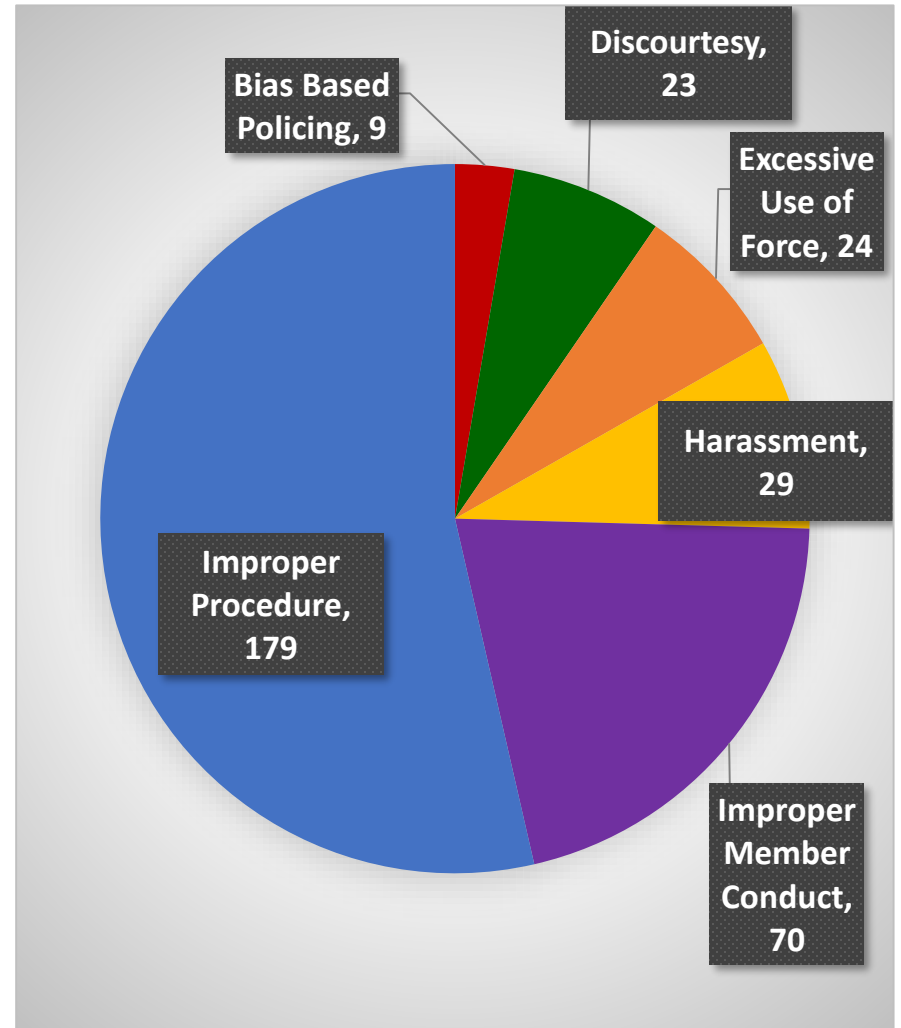
Examples of non-KCPD complaints include those against other police departments, city offices, non-Law Enforcement personnel, neighbor disputes, barking dogs, homeless camps, illegal parking, etc.

Investigations



The Complaint Process - Investigation



When a complaint is filed at the Office or received from a satellite location, it is reviewed by an analyst, where it is classified into the appropriate category, entered into various databases, and a file is prepared for the Internal Affairs Unit. The complaint is then assigned to an Internal Affairs detective, who prepares an investigative file consisting of statements from the complainant(s) and subject Department member(s); police reports; dispatch records; in-car and body-worn camera footage; medical records (if applicable); witness statements; injury photos; and any other documentation and/or video which may exist.

After the investigation is complete, the complaint file is returned to the Office where it is randomly assigned to an analyst, who reviews the case file and applicable Departmental policies and procedures. The findings are then sent to the Board of Police Commissioners and to the Chief of Police, who by Missouri state statute is the only person who can impose disciplinary action. After the complaint is completed, the complainant is notified by mail of the outcome of the investigation. The entire process, from intake to recommendation, is allotted 90 days per Missouri state statute. Corrective and/or disciplinary action has an additional timeframe to meet.

Complaint Dispositions

Sustained

The alleged act occurred and was without lawful police justification.

Not Sustained

The evidence fails to prove or disprove that an act of misconduct occurred.

Exonerated

The alleged act either did not occur or the act did occur but the Department member engaged in no misconduct because their actions were lawful, justified, and/or proper.

Closed

The complaint was closed due to lack of jurisdiction, pending litigation, criminal investigation, third-party complaints without a complaint from the aggrieved party, or no violation of policy or procedure. This is not an exhaustive list.

Withdrawn

The complainant indicated they no longer wished to pursue the complaint after it was filed.

Non-Cooperation

The complainant failed to cooperate with the investigation. (This can also refer to those handled internally in the Office of Community Complaints.)

Complaints Reviewed in 2024

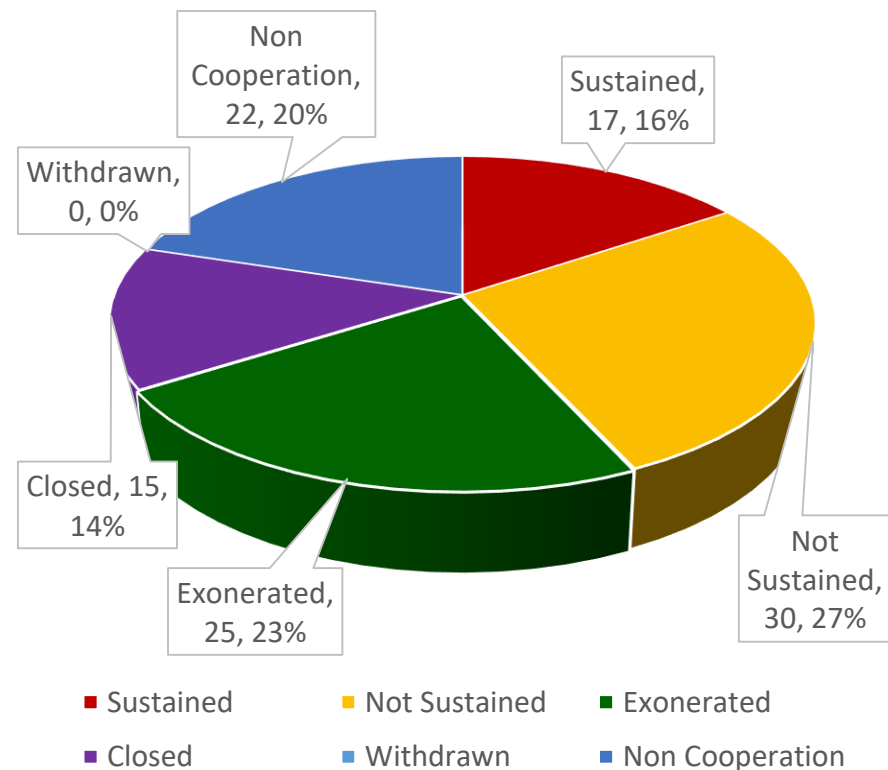
In 2024, 109 complaints were investigated by the Internal Affairs Unit, consisting of those filed in 2024 and the latter part of 2023.

The following were the types of complaints investigated by Internal Affairs:

On the pie chart to the right, you will see that only 72 complaints received full and complete investigations and had a recommendation made by the Office of Community Complaints of Sustained, Not Sustained, or Exonerated.

The remaining complaints were administratively closed by OCC or closed for lack of cooperation.



Sustained Complaint Investigations

Of the 17 sustained complaints in 2024, two (2) were sustained for Harassment, ten (10) were sustained for Improper Member Conduct, and five (5) were sustained for Improper Procedure.

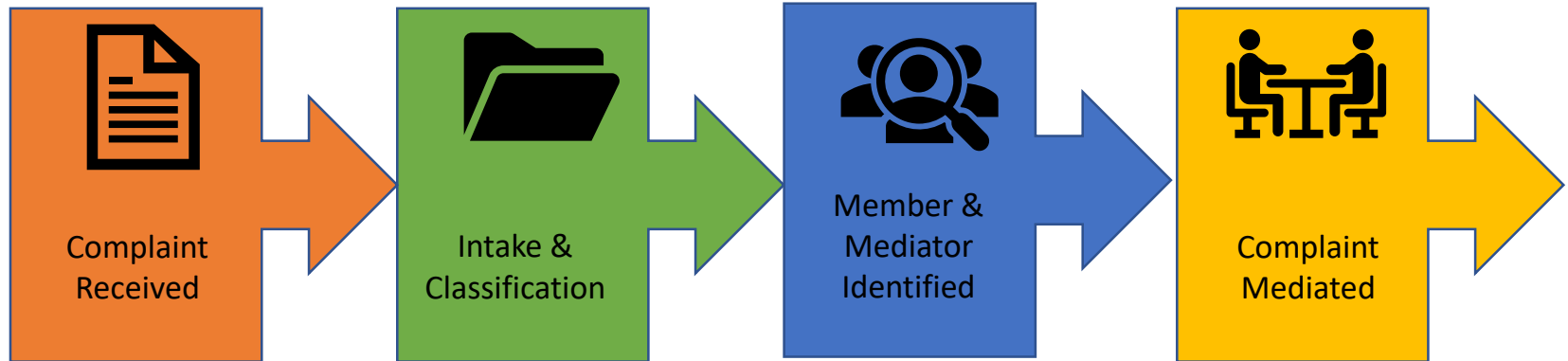

Mediations and Conciliations

Two alternative methods to a formal investigation



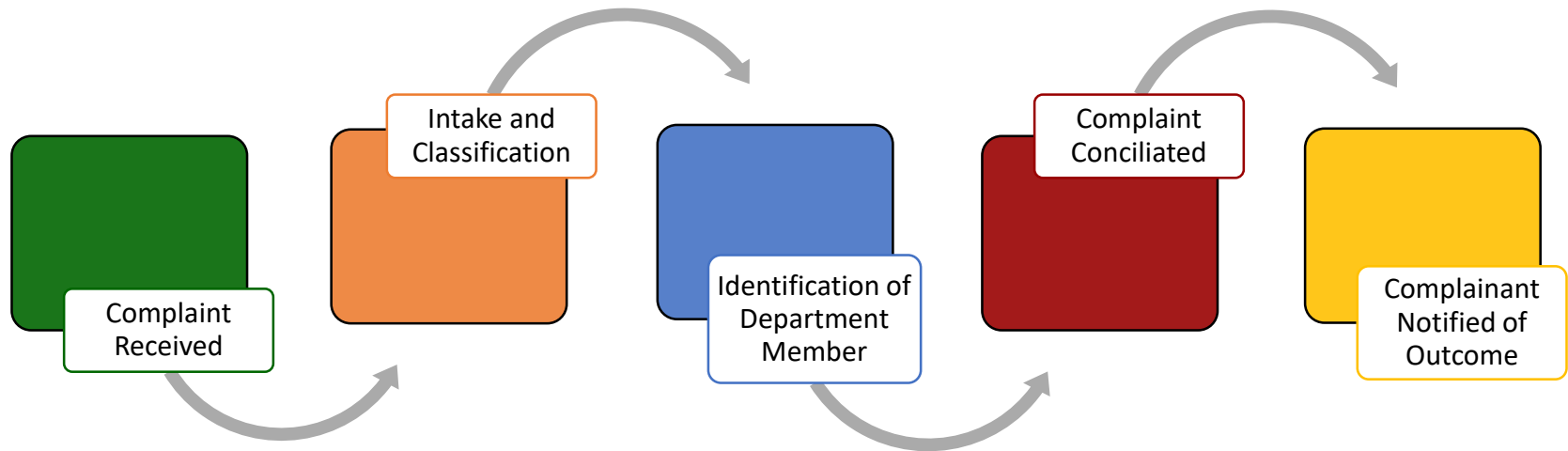
The Complaint Process – Mediation



One of the alternative methods of handling a complaint is for a complainant and Department member to participate in mediating the complaint. Mediation is a voluntary process where the parties in a dispute (i.e. complainant, Department member) meet with an independent, trained, third-party mediator that helps to resolve the problem in a manner that all parties can find agreeable. Mediation is voluntary on the part of the complainant and Department member. No disciplinary action will be taken against either party. It is confidential, controlled, and collaborative. It is impartial, neutral, balanced, and safe and often satisfactory to all participants.

In 2024, two **(2)** complaints were resolved successfully by bringing together the complainant, the subject member(s) and independent mediators.

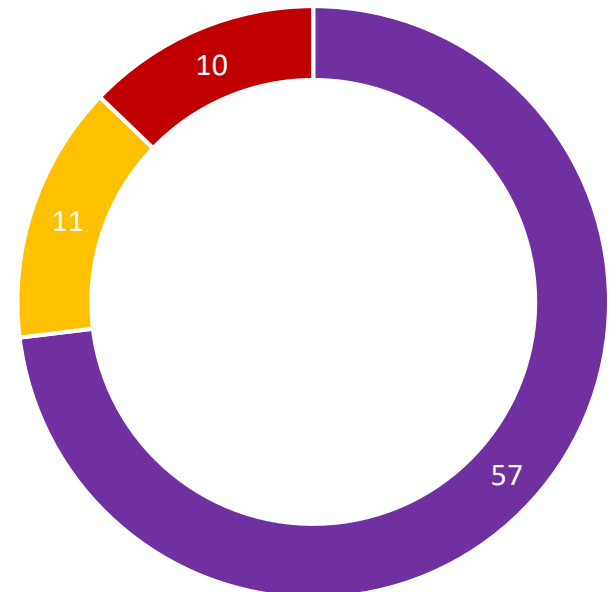
The Complaint Process – Conciliation



Conciliation is another alternative method of resolution to a complaint. In a conciliation, the complaint is forwarded to a commander. The commander or their designee contacts both the complainant and the Department member, conducts a mini investigation, and reports back to the complainant the actions that were taken. Types of complaints suitable for conciliation are:

- Errors in police reports
- Clarification or education on Departmental policy and procedure
- Interpretation of local laws, city ordinances, and state statutes
- General customer service issues

- Conciliation - Successful
- Conciliation - Unsuccessful
- Conciliation - Noncooperative

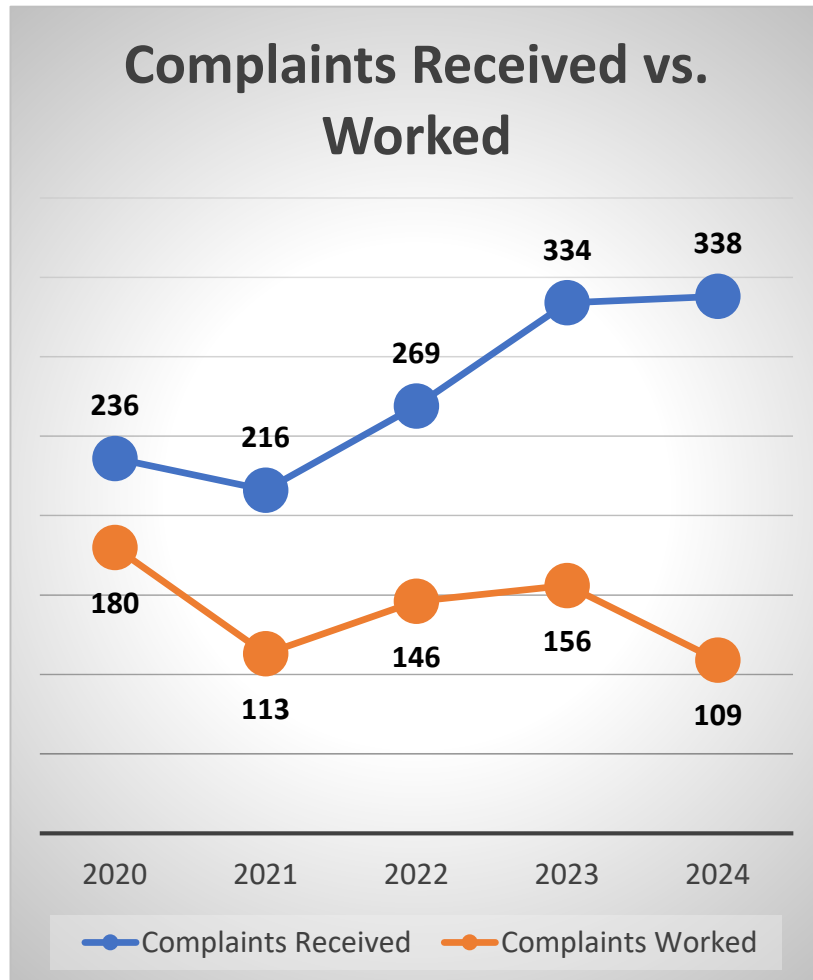


Historical Comparison and 5 Year Trends



Historical Comparison – 5 Year Trends

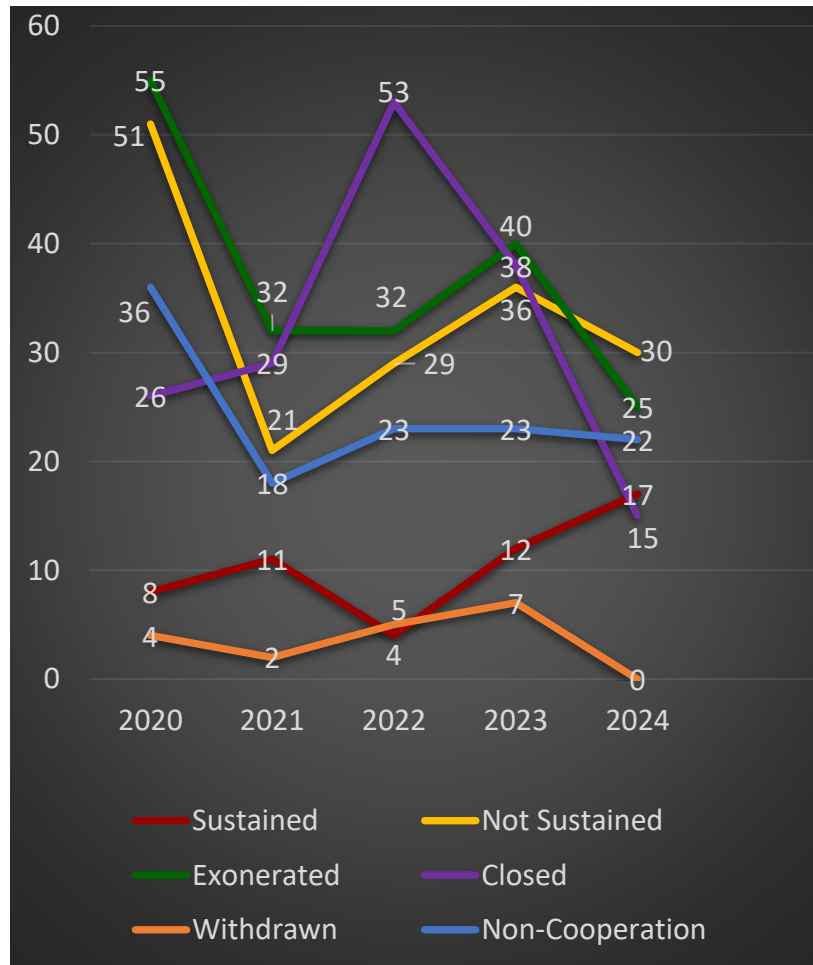

Although the number of complaints reviewed fluctuates each year, the breakdown of sustained complaints averages approximately seven (7) percent each year. However, it should be noted that sustained complaints as a percentage of all fully worked complaints (those with a recommendation of sustained, not sustained, and exonerated) has risen to approximately thirteen (13) percent.

Enabling Legislation



Enabling Legislation:

Missouri State Statutes, Chapter 84, §84.430

Board of police--personnel disciplinary cases--decrease of force-- witnesses, summons and administration of oaths (Kansas City).

1. **The board shall hear all complaints or charges filed against any member of the police department.**
All complaints or charges filed by persons other than the commissioners or police officers shall be verified by the oath of the person filing such complaints or charges. The board may at any time order the discharge of a specified number of police officers for the reason that in the opinion of the board, the police force is larger than the interests of the public demand or that there is insufficient money to pay the expenses of maintaining the police force as then organized; and in such cases it shall not be necessary to file any complaint or charges or to permit a hearing by the board of the policemen or police officers to be removed; but policemen and police officers so dismissed shall be placed at the top of the suitable eligible lists, and when vacancies so created shall be filled the policemen or police officers thus removed shall, if they so desire, be reappointed to fill such vacancies in the order in which such policemen or police officers were removed.
2. Any member of the board shall have power to summon and compel the attendance of witnesses before the board and the production of books and papers before them whenever it may be necessary for the more effective discharge of the board's duties and responsibilities. Any member of the board or the secretary of the board shall have the power to administer oaths or affirmations to any person appearing or called before said board.

Missouri State Statutes – Chapter 590

Missouri State Statutes, Chapter 590, §590.502, 2, (11-14)

(11) The law enforcement agency conducting the investigation shall have ninety days from receipt of a citizen complaint to complete such investigation. The agency shall determine the disposition of the complaint and render a disciplinary decision, if any, within ninety days. The agency may, for good cause, petition the administering authority overseeing the administration of discipline for an extension of time to complete the investigation. If the administering authority finds the agency has shown good cause for the granting of an extension of time to complete the investigation, the administering authority shall grant an extension of up to sixty days. The agency is limited to two extensions per investigation; except that, if there is an ongoing criminal investigation there shall be no limitation on the amount of sixty-day extensions. For good cause shown, the internal investigation may be tolled until the conclusion of a concurrent criminal investigation arising out of the same alleged conduct. Absent consent from the officer being investigated, the administering authority overseeing the administration of discipline shall set the matter for hearing and shall provide notice of the hearing to the law enforcement officer under investigation. The officer shall have the right to attend the hearing and to present evidence and arguments against extension;

(12) Within five days of the conclusion of the administrative investigation, the investigator shall inform the officer, in writing, of the investigative findings and any recommendation for further action, including discipline;

(13) A complete record of the administrative investigation shall be kept by the law enforcement agency conducting such investigation. Upon completion of the investigation, a copy of the entire record, including, but not limited to, audio, video, and transcribed statements, shall be provided to the officer or the officer's representative within five business days of the officer's written request. The agency may request a protective order to redact all personal identifying witness information; and

(14) All records compiled as a result of any investigation subject to the provisions of this section shall be held confidential and shall not be subject to disclosure under [chapter 610](#), except by lawful subpoena or court order, by release approved by the officer, or as provided in section [590.070](#).
